

School Cancellations & Make-Up Days

GOALS

- To limit the number of cumulative days for e-learning in a school year. We would want to have at least 174 out of 180 days of in-school instruction.
- To limit the number of consecutive eLearning make-up days to no more than three.

2019-2020

Scheduled E-Learning Days September 25, 2019 & April 8, 2020

Preventative Action for exceeding 6 E-Learning days in a school-year:

- On the 6th eLearning day on or before April 7, 2020, we will change April 8, 2020 to an in-school instruction day.

Hypothetical:

1. 9/25/19 - *Planned eLearning Day*
 2. 1/7/20 - *Snow Day eLearning Day*
 3. 1/23/20 - *Snow Day eLearning Day*
 4. 2/6/20 - *Snow Day eLearning Day*
 5. 2/7/20 - *Snow Day eLearning Day*
 6. 3/9/20 - *Snow Day eLearning Day*
 7. 4/8/20 - *Planned eLearning Day* **TURNED INTO IN-SCHOOL DAY**
- If school is canceled causing a 7th day or beyond of eLearning, we would have In-School Days on the following days
 - 2/17/20 (If the 7th day is before)
 - 5/29/20 (teacher only day & graduation day)

Preventative Action for exceeding 3 consecutive eLearning Days:

- For 2019-2020, we will not implement any preventative action for consecutive eLearning Days.

2020-2021

Scheduled E-Learning Days September 23, 2020 & April 7, 2021

Preventative Action for exceeding 6 E-Learning days in a school-year:

- On the 6th eLearning day on or before April 6, 2021, we will change April 8, 2020 to an in-school instruction day.
- If school is canceled causing a 7th day or beyond of eLearning, we would have In-School Days on the following days
 - 2/15/21 (If the 7th day is before)
 - 5/27/21 (teacher only day)
 - 5/28/21 (graduation day)

Preventative Action for exceeding 3 consecutive eLearning Days:

- On the 4th consecutive school cancellation day, we would make-up instruction on the following days in this priority order:
 - 2/15/21 (If 4th consecutive day is on or before Thursday, February 13, 2021)
 - Saturday 3/7/21 - eLearning Day Option
 - eLearning Day IF we don't exceed 6 cumulative days of eLearning before 3/6/21
 - We will NOT use this option for an in-school day
 - Saturday 4/4/21 - eLearning Day Option
 - eLearning Day IF we don't exceed 6 cumulative days of eLearning before 4/3/21
 - We will NOT use this option for an in-school day
 - Saturday 4/18/21- eLearning Day Option
 - eLearning Day IF we don't exceed 6 cumulative days of eLearning before 4/17/20
 - We will NOT use this option for an in-school day
 - 5/27/20
 - eLearning Day IF we don't exceed 6 cumulative days of eLearning
 - IF we exceed 6 cumulative days of eLearning, this will be an IN-SCHOOL DAY
 - 5/28/21
 - eLearning Day IF we don't exceed 6 cumulative days of eLearning
 - IF we exceed 6 cumulative days of eLearning, this will be an IN-SCHOOL DAY
