
Legal Guidance Related to COVID-19 and Schools

• School boards have the jurisdiction to implement routine prevention measures they deem necessary to protect the health of students and staff, such as masking, distancing, and disinfection.

• Two Mandates related to COVID-19 in Indiana

- Masks while Riding a Bus (USDOT)
- Contact Tracing & Quarantine/Isolation
 - Executive Order 21-19 issued on July 29, 2021 supports the IDOH's guidance on COVID-19 issued on July 9, 2021.
 - Duty to report COVID+ cases and conduct contract tracing
 - Failure to report is a Class B misdemeanor according to the Indiana Communicable Disease Statute (IC 16-41-2)

Guiding Principles in Developing & Revising our Health & Safety Protocols



- 1. Adhere to state and federal laws regarding health & safety related COVID-19.
- 2. Align our protocols with guidance from state and county health departments.
- Prevent as many students and staff from missing school due to illness, including COVID-19.
- 4. If students and staff do have to miss due to COVID-19, then we want to get them back in school as quickly and safely as possible.
- 5. Maintain a safe & healthy learning environment for our students, staff, and community members who come to visit our campuses.

Health, Safety, & Facilities Protocols for 2021-2022 School Year DRAFT UPDATE 2021-8-15

Health, Safety, & Facilities Protocols for 2021-2022 School Year

- Each level is specific to one building and data to inform a change will be only that building's data.
- Once a school is advanced to a higher level, they will remain there for a minimum of 5 school days.
- Systematic protocols to keep students, families, faculty/staff and the surrounding community safe and healthy.
- Essential actions in alignment with CDC guidelines, Indiana Department of Health and Hancock County Health Department. This includes wearing a mask at all times while traveling on a school bus.
- All procedures are contingent upon any guidance provided by appropriate public health agencies.

GREEN. MVCSC to start the 2021-2022 school year under traditional guidelines with masks for unvaccinated and vaccinated individuals being encouraged, but not required.

- ELEMENTARY 0 to 1 students/staff are COVID positive
- MIDDLE SCHOOL 0 to 2 are COVID positive
- HIGH SCHOOL 0 to 4 students/staff are COVID positive

BLUE.

- Absentee rate of 12% due to combined illness of students and staff within an individual building. AND/OR
- ELEMENTARY 2 to 3 students/staff are COVID positive
- MIDDLE SCHOOL 3 to 6 students/staff are COVID positive
- HIGH SCHOOL 5 to 8 students/staff are COVID positive
 - Start additional sanitizing procedures
 - Daily sanitizing of surfaces and objects that are touched often.
 - Restrict use of water fountains (close bubblers). Students must use a water bottle or cup.

YELLOW.

- Absentee rate of 14% due to combined illness of students and staff within an individual building. *AND/OR*
- ELEMENTARY 4 to 6 students/staff are COVID positive
- MIDDLE SCHOOL 7 to 10 students/staff are COVID positive
- HIGH SCHOOL 9 to 13 students/staff are COVID positive
 - Continue daily sanitizing
 - Begin fogging the building
 - Begin fogging between all bus routes when any school is at 14%
 - Students and staff will be encouraged to wear masks

Orange.

- Absentee rate of 16% due to combined illness of students and staff within an individual building. AND/OR
- ELEMENTARY 7 students/staff are COVID positive
- MIDDLE SCHOOL 11 students/staff are COVID positive
- HIGH SCHOOL 14 students/staff are COVID positive
 - Students and staff will be required to wear masks (Close Contacts move from 6' to 3')
 - Deep cleaning- all surfaces cleaned after all activities within the building and classrooms
 - Daily fogging of building

Red. Absentee rate of 20% due to combined illness of students and staff within an individual building.

MVCSC will consult with Hancock County Health Department on possible closure •

Preventive Cleaning Procedures:

- Deep clean during all extended breaks
- Deep clean during flu season (October-March)






Fortville Elementary - 2020/21 School Year COVID+




McCordsville Elementary - 2020/21 School Year COVID+

Significant Changes from the IDOH

- Students who are 3' to 6' from an identified positive case do not have to quarantine provided that the positive case and close contact(s) is/are wearing a mask.
- Contact Tracing on the bus is now 3' because everyone is masked on the bus.

Supporting Students Who Are Out on Quarantine

- Assignments and materials will be provided no later than 48 hours after teachers are notified of close contacts.
- In most cases assignments will be given for the duration of the quarantine period or at the very least a week's worth at a time.
- Assignments/materials will be pushed out electronically in most cases via Canvas or Google Meet; printed materials or supplies may be picked up from school, as needed.
- Both direct and/or indirect instruction will be provided.
 - Direct: classroom teachers, specialists, and other support staff.
 - Indirect: links to videos, recordings, other resources

Supporting Students Who Are Out on Quarantine

- Instruction and Check-ins will be conducted by teachers, specialists, other support staff.
- Assistance and Follow-up will be provided by classroom teachers, specialists, counselors, administrators, and other support staff members. In most cases, times will be provided as to when assistance will be available.
- Students and parents are encouraged to reach out to ask questions, seek further guidance or assistance when needed, as well. Ask students/parents to allow teachers and other support staff a reasonable amount of time to get back with them.

Supporting Students Who Are Out on Quarantine
