Thank you for allowing Denney Excavating, Inc. (DEI) to provide the following proposal for your consideration. DEI proposes to supply the labor, equipment, and materials to provide demolition services at the above-referenced location as outlined below:

## Scope of Work

- Provide demolition permits and notification to state and local agencies as required for demolition activities.
- Provide site specific safety controls for demolition work including barrels, and danger tape and orange fence around open holes and excavations.
- Provide proper removal and disposal of freon in existing condensing units.
- Remove office structure completely including concrete slabs, footings , and foundations.
- $\circ$   $\;$  Remove bus barn completely minus a portion of slab to remain.
- Remove two antennas and trees as noted.
- o Backfill and compact foundation and crawl space voids with onsite fill material.
- Provide proper disposal of all materials at approved sanitary solid waste landfill, clean fill, or recycling facility.
- DEI is to retain all salvage rights.
